

SI. No.	The school is directed to ensure that :
1	School is not maintaining the Mandatory Public Disclosure link maintaining at its website with all the mandatory documents and information uploaded for general public. As per Board guidelines and circular no 09/2021 the school should have a functional website with all mandatory documents available on the Mandatory public disclosure link for easy access to the public on school website in compliance of Circular No : 09/2021 Date of (21 May 2021) - Display of "Mandatory Public

	Disclosure" at Home Page in school's website under prominent icon leveled as "Mandatory Public Disclosure"). School shall develop and provide the Mandatory Public Disclosure link on website within 03 months and submit the compliance.
2	The school is not covered by the Boundary wall of appropriate height from all sides making the campus safe for the students and the staff. The school boundary wall is not complete from two sides posing safety concern. As per affiliation bye laws clause 3.1.5. The land mentioned in 3.1.1 above should be surrounded on all sides by a pucca boundary wall of sufficient and adequate height. School shall increase the height of boundary walls from all sides. School shall construct the Boundary wall and bound the school land from all sides within 03 months and submit the compliance.
3	Biology Lab is under stocked and not properly arranged as per SoPs and Board guidelines with recommended infrastructure. The workstations are temporary and the equipment are arranged on the wooden tables as makeshift arrangement. No heating facility and wash basins seen. Further, lab has insufficient models and plant specimen with safe storage. School is directed to follow the SoPs and upgrade the lab with requisite infrastructure and facilities and upload the compliance on SARAS portal within 03 months.
4	Math lab is temporarily arranged with limited instruments and aids on small tables which is not as per SoPs and Board guidelines. The lab is arranged as a makeshift arrangement with small tables as work stations and not suitable for project/practical works to accommodate 40 students at one time. School is directed to follow the SoPs and Board guidelines for Math lab and upgrade the lab with proper work stations and stock and upload the compliance on SARAS portal within 03 months.
5	The library is poorly stocked with temporary iron racks and the books are not properly arranged and catalogue for library function with maintenance of accession register. Books and journals under different categories are not available as required by SoPs and Board guidelines. More library collection of classics, autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational materials is required to be added. School is required to upgrade the library as per SoP and circular no 11/2022 and upload the compliance with video link on SARAS portal within 03 months.
6	Computer lab is arranged in the room created by partitioning the hall with aluminium sheets on one side. Further, the number of computers are less than 40 whereas there should be 40 computers with net connectivity. School is directed to upgrade the computer lab with recommended infrastructure and facilities and shift the computer lab in permanent room of recommended size and dimension and upload the compliance with video link within 03 months on SARAS portal.
7	CwSN toilets are still small in size and not suitable to use by the wheelchair bound person. School has made no effective changes and amendments in CwSN facilities. School is directed to make arrangements of CwSN toilets at each floor separately for boys and girls should be made with all facilities as per board guidelines vide circular no 05/2023 and compliance with video link be uploaded on SARAS portal within 03 months.

The school shall ensure the mandatory training of its teachers with CoE, Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/-every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
