




**Minutes of the School Level Fee Committee (SLFC) meeting held on 23 Sep 2024.**



5. **Agenda No 3 Proposed School Fee for the Academic session – 2025-26**
- Deliberations were made on the fee proposal proposed by the School. A review was done of the Audited income and expenditure statement.—Infrastructure made available to the students for the qualitative education, the facilities provided, the education standard of the school and the expenditure incurred on administration and maintenance were considered. Estimated expenditure for the next three years also discussed in the detail.
